LANKA MAHAVIDYALAYA, LANKA, HOJAI, ASSAM, hereinafter referred to as "LM" and ALHAZ SUNAI BIBI CHOUDHURY COLLEGE, UDALI, HOJAI, ASSAM, hereinafter referred to as "ASBCC", hereinafter individually referred to as "the Party" and jointly referred to as "the Parties";

ACKNOWLEDGING that;

1. LM is a Degree level provincialised educational institution, having its address as Lanka, Hojai, Assam India, 782446.
2. ASBCC is a Degree level provincialised educational institution, having its address as Udali, Hojai, Assam-782446

DESIRING to; support the cooperation between the Parties in education and research programs;

PURSUANT to the prevailing laws and regulations, policies and procedures that govern the provincialised colleges in the state of Assam.

HAVE REACHED the following understanding: -

ARTICLE 1  
OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to cooperate in educational projects in areas of mutual interest.

**ARTICLE 2  
SCOPE OF COOPERATION**

The Parties agree to implement cooperation program including but not limited to:

- a. Faculty and student exchange
- b. Curriculum development of certificate and diploma courses
- c. Cooperation during conduct of student study tours
- d. Undertaking joint research at the faculty level
- e. Facility exchange relating to laboratory, ICT and Library Resources
- f. Any other areas as mutually agreed upon by the Parties

**ARTICLE 3  
LOCATION OF ACTIVITIES**

1. The Parties agree to implement the programs stated in ARTICLE 2 at LM and ASBCC.
2. Any changes to the location of the programs shall be mutually agreed upon by the Parties.

**ARTICLE 4  
EXECUTING AGENCIES**

To implement this MOU: -

1. LM appoints the Coordinator, IQAC, LM (hereinafter referred to as LM Rep)
2. ASBCC appoints the Coordinator, IQAC, and ASBCC (hereinafter referred to as ASBCC Rep).

**ARTICLE 5  
FINANCIAL ARRANGEMENT**

1. Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
2. Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

**ARTICLE 6  
INTELLECTUAL PROPERTY RIGHTS**

1. Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.
2. In case of specific arrangement, programs or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

**ARTICLE 7  
CONFIDENTIALITY**

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MOU, the disclosing Party shall have prior written consent of the other Party.

**ARTICLE 8  
LIMITATION OF PERSONAL ACTIVITIES**

The Parties shall ensure that their personnel engaged in the activities under this MOU shall engage only in activities under the framework of this MOU with respect to laws and regulations in the state of Assam and the country of India.

**ARTICLE 9  
SETTLEMENT OF DISPUTES**

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultation or negotiation between Parties.

**ARTICLE 10  
AMENDMENT**


1. This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MOU.
2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

**ARTICLE 11  
ENTRY INTO FORCE, DURATION AND TERMINATION**

1. This MOU shall enter into force on the date of signing.
2. This MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by mutual consent of the Parties.
3. Either Party may terminate this MOU at any time by given written notification to the other Party on its intention to terminate this MOU, six (6) months prior to the date of the termination.
4. The termination of this MOU shall not affect the completion of any programs or projects in progress and not completed at the time of termination.




