1.0 ROLE OF MS-Seven

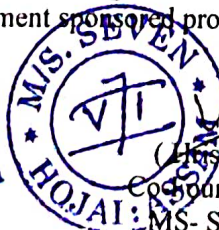
- 1.1 Periodic monitoring and screening of students of Lanka Mahavidyalaya, Lanka, Assam.
