

#### MEMORANDUM

The undersigned hereby offers to Mr. Antendra Cheuhan Son of Sh. Ram Rej Chauhan a post of Constable (General Duty) in the minimum pay of Rs. 21700-691001- in the Pay Matrix (Level-3) in Sashastra Seema Bai. - The terms and conditions of appointment are as follows:-

With reference to your application for the post of <u>Constable (GD)</u> in CAPFs, AR, NIA, and SSF through SSC Examination-2022 and result declared by SSC on dated 20.08.2023 I am directed to inform you that you have been provisionally selected for the post of <u>Constable (GD)</u> in BSF in Revised Pay matrix Level-3 of 7th CPC i.e. Rs. 21,700 to 69,100/- and other allowances as admissible to Central Govt. employees from time to time subject to following terms and conditions:-
