3. ELEGIBILITY OF CANDIDATES AND VOTERS:

- a. All regular students of Lanka Mahavidyalaya for the session 2024-25 shall have the right to vote in the election
- b. Each voter shall have to come in full prescribed college uniform along with his / her identity card at the time of casting of vote.

c. A student shall become eligible as candidate / proposer of a candidate/ seconder of a proposal if his / her college dues are cleared for the entire session, 2024-25 provided that he / she has 75% class attendance in each subject.

d. A student who stood as candidate against any post for the Election to Students' Association Lanka Mahavidyalaya, Lanka till the session 2023-24 shall not be eligible as candidate against any post.

e. One student shall be able to stand for one post only.

f. Students of TDC-IIIrd Year (5th Semester) class only will be able to stand for the post of President & Vice President.

g. The General Secretary shall not be a student of H.S. IInd Year class and TDC-IIIrd Year (5th Semester) class.

h. For the post Boys' Common Room Secretary the candidate, proposer and seconder must be male student and for the post of Girls Common Room Secretary, the candidate, proposer and seconder must be a female student.

i. For the post of Class Representative of a certain class the candidate, proposer and

seconder must belong to that class.
