# **1. EXECUTIVE SUMMARY**

# **1.1 INTRODUCTION**

The Lanka Mahavidyalaya, Lanka, Nagaon, Assam, affiliating to Gauhati University, enlisted under 2(F) and 12(B) by University Grants Commission, situated in a underdeveloped Schedule Cast Area, completed 44 years of existence on 19th July, 2023, is a premier institute of Arts and Commerce education in the district of Hojai (Nagaon), Assam, in the bank of a beautiful big pond of area about 8 acres of land with beautiful green surroundings.

The College is about 175 KM from Guwahati, the Capital city of Assam. The college started initially with Arts stream in the year of 1979, and later the Commerce stream added in the year of 1990. At present the college is offering 22 Under Graduate (UG) Programs and 12 Certificate Courses in regular mode. At present the enrollment is with a student's strength of 1997 with a faculty strength of 35 and other 6 positions appointment are in process.

The result of end semester examinations on last five years is 63.71 in average.

The College is Accredited by NAAC for the 1st Cycle in the year of 2005 in 'B' grade and in the year of 2015 for 2nd Cycle also with 'B' Grade.

Also, the College is offering Voluntarily the Higher Secondary (HS) Course of both Arts and Commerce stream under Assam Higher Secondary Education Council since long.

Further, the College is offering 12 UG Programs, 6 Post Graduate Programs(PG) in Distance Mode under Krishna Kanta Handique State Open University (KKHSOU). Also, the college had offered Diploma in Elementary Education till 2018 and Bachelor Preparatory Program for 5 years till 2017 under KKHSOU.

The college has 34 class Rooms, out of which 07 equipped with LCD projectors.

There are one Seminar Hall with LCD Projector/ Smart Board, One Digital Class Room with LCD Projector/Smart Board, 02 Big Computer Laboratories and an Education Laboratory.

The College received and utilized Rupees Two Crore (2 Crore) RUSA Grant under infrastructure grants to college.

The college has 24 hours CCTV vigilance system for monitoring & Security purposes regarding smooth and secure functioning of the institution.

The College has a Girls Hostel with about 30 Seats in its campus.

The Lanka Mahavidyalaya Staff Co-operative Society, a registered financial organization under Government of Assam Society Act, established in the year of 1989, which is one of the best practices of the college.

#### Vision

The prime vision of Lanka Mahavidyalaya is to provide and promote quality and value education to instill spirit of inquiring humanistic value, inculcate the sense of scientific temperament among the students in particular and society in general to cop up themselves with the changing scenario as a citizen of Democratic India.

The leading citizens of greater Lanka Area, District- Hojai (Nagaon), Assam in the year of 1979 established this institute to impart higher education in this backward area, with an vision to educated the socioeconomically backward people, where majority of the inhabitants belong to Schedule Cast.

ix. As most of the students are from rural areas, so they makes the best uses of the Library.

x. Among alumni of Lanka Mahavidaylaya, unemployment rate is very low.

- 1. The College is affiliated to Gauhati University and it follows the syllabus, academic calendar and guidelines framed by the affiliating university.
- 2. The institution has an academic council, formed vide notification no. LM-G/09/2017/pt/ 5183, dated 11/12/2017, which formulates and ensures curriculum planning in association with Management and IQAC.
- 3. Th Academic Council of the college prepares prospectus for the students to have a glimpse of the curriculum followed by the college.
- 4. The Academic Council prepares Central Class Routine and also each Department prepares class routine so as to cover all the courses as per University regulations.
- 5. For the slow learners and other students desirous of clearing their doubts and queries, there is a provision for additional remedial, tutorial and practical classes arranged by the concerned departments.
- 6. Each department prepares a well designed Teaching Plan to have effective impact on the learning process for the students.
- 7. The Sessional Examinations, group discussion, presentation on course contents are conducted as a part of internal assessment and for the overall development of the students.
- 8. On the basis of monthly work load, every teacher maintains their diaries to record day to day activities which is checked by the HODs and it further forwarded to the Academic Coordinator for counter verification.
- 9. Departments conduct departmental meetings at regular intervals to analyze the progress of the course.
- 10. The Online feedback of the students is taken regularly in each year and the academic council discussed and took necessary measures to fulfill the needs of the students as per students Feedback.
- 11. Further, taking of Teachers' Feedback from the session 2021-22 and Guardian Feedback along with Alumni Feedback also is in practice from the session 2022-23.

10. For Students Satisfactory, total current students of 1997 are uploaded in 2.7.1 and about 60.24 % students' details are uploaded in SSS format.

1. Research Grants: The Institute received total Grants of Rs. 24.23 Lakhs for Research Projects and endowments, out of which 22.75676 Lakh for Research Project and 1.47055 Lakh as Travel Grant for presenting Research Paper in USA.

3. FDP/ Workshops and Seminar/ Webinars : The Institute conducted about 65 various programs, out of which one FDP, about 24 webinars of International, National and Institutional Levels relating to Research, Students support system, social awareness etc, and about 33 Workshops and many other Departmental level activities.

4. Full Time Teachers and Publications in Five years: The Institute has 32 publications in UGC Care-Listed (or valid UGC approved List) Journals and 39 Book Chapters / Full Books against 48 faculties without repetition.

5. **The institute conducted various** extension activities, out of which 22 activities are prominent and it received about six prizes for its extension activities.

6. Number of extension and outreach programs conducted by the institution is about 50.

Lanka Mahavidyalaya has always been a student-centric institution. Student mentoring and support has been a primary focus of the college.

- 1. 83.6 Percent of students benefited by scholarships and freeships provided by the government under various schemes and data has been incorporated with sanction letter.
- 2. The institution adopted various measures for the students for the enhancement of the skills like Soft skills, Language and communication skills, Life skills (Yoga, physical fitness, health and hygiene) & ICT/computing skills.
- 3. 12.56 percent of students have benefitted by the guidance for competitive examinations and career counseling offered by the Institution during the last five year. Particularly during the session 2021-22, the college in collaboration with MS-7 (Rout to Success) offered campus placements to 47 Students.
- 4. The institution adopts both Online and Offline Mechanisms for redressal of student grievances including sexual harassment and ragging cases. The college formed Internal Complaint Committee, Anti Ragging Squad, Discipline Maintenance Committee, and Women Cell regarding the deployment of the students Grievances.
- 5. 21.69 Percent of students has placed and progressed to higher education after their graduation from this Institution. The supporting data has been uploaded in the college website.
- 6. 3.53 percent of students qualifying in state/national/international level examinations during the last five years.
- 7. The institution has achieved their success in promoting the students to participate in Number of Cultural and Sports Activities organized by various institutions nationally and internationally. During the session 2022-23, one of our students has participated in the International Karate Championship 2022 and secured 1st Position in the Individual KUMITE in the Cadet and 2nd Position in the Individual KATA in the Cadet.
- 8. The college conducted various cultural and sports activities for the overall development of the students. Particularly, the college has organized Annual Sports Week every year.
- 9. Although, the College has not a registered Alumni Cell, our Alumni Association works for the overall development of students as well as the institution. It helps our institution not just financially, but in terms of academic planning, placements of students, career guidance and technological guidance.

1. Multidisciplinary/interdisciplinary:	Multidisciplinary education is a concept that has been embraced by the Indian government through the new National Education Policy (NEP) 2020. This approach to learning looks at how different disciplines can interact and overlap with each other to create a comprehensive understanding of a subject.
	Although, the institution adhere to the Multidisciplinary/ Interdisciplinary Approaches from the very inception of the CBCS System under the Affiliating University, the College worked with new vigour and zeal in this task, after the introduction of the NEP-2020 for the utmost acquirement of the policy introduced from the session 2023-24. The College has both Arts and Commerce Stream , and

2. Academic bank of credits (ABC):	The Academic Bank of Credit referred to as ABC in short, is a virtual mechanism that will deal with the credits earned by the students of Higher Education Institutes in India and which are recognized by the University Grants Commission (UGC). As per the guidelines and notifications from the Government of Assam, the Institution has introduced the NEP-2020 from the session 2023-24. Thus, as a part of NEP-2020, the ABC ( Academic Bank of Credits) also been adopted by the college under the SAMARTH portal , Government of Assam. At present, all the First Year Four Years UG Program Students registered themselves with ABC ( Academic Bank of Credit ), as per instruction of the Gauhati University, the affiliating University of this Institute.
	hence the college is offering to the students to choose any subject from both Arts and Commerce as per CBCS system from 2019 and NEP-2020 from 2023. The Institution has a good orientation among all departments both Arts and Commerce Faculty regarding Seminars and Workshops. Both the Teachers and Students participated in Talks, Workshops and Seminar / Webinars organized by various departments and IQAC. Further, many Teachers carried their PhD in interdisciplinary & Multidisciplinary topics. Also, many faculty members had done interdisciplinary and multidisciplinary joint publications in research. The Department of Assamese and Commerce offered Multidisciplinary course curriculum with joint effort of IT Department. The Department of commerce course curriculum is enriched with Mathematics and Statistics. Further, the Department of commerce offered multidisciplinary common courses to all the students of Arts and Commerce. The College introduced 12 Add-On- Certificate courses for all the students irrespective of their UG Program and the Institute is offering Computer oriented and Value added courses like Basic Computer Applications, Yoga, Assamese DTP, Bangla DTP etc. , which are mainly inter disciplinary in nature. Introduction of courses like IT in Business, Business Mathematics, Business Statics by commerce stream of this institute from its very inceptives are mainly multidisciplinary in nature. The College has two Big Computer Labs , which are always open for every department to introduce new multidisciplinary courses.

3. Skill development:

As the main objective of NEP-2020 is to foster the Entrepreneurship rather than the Placements, the affiliating University has introduced various Skill Enhancement, Value Added and Multidisciplinary Courses for creating better opportunities among the Students in the Job/service Sector. So, the institute is offering all Skill Enhancement and Value added multidisciplinary courses as prescribed by its affiliating University, the Gauhati University, Assam. Along with this, The College is also encouraging the students for Job oriented Skill Development Programs under Assam Skill Development Missions ( ASDM) from time to time, by offering job oriented Skill Development Programs . The College signed MoU with few Assam Skill Development Mission's partner Training Institutes, viz. Indian Skill Academy & Job Hut, Guwahati; MS-7 : Rout to Success, Hojai, Assam and Skillfinity, Guwahati, Assam . During session 2020-21, Indian Skill Academy Selected 78 Final Year Students for Job Oriented Skill Development Courses in its Campus at Guwahati. But Due to covid-19 problem, all the students could not continue their courses and only 4 students got placement after completing the course . Another organisation, "MS-7: Rout to Success" Selected 50 students for Job oriented Skill Development course ,"Retails Sales Associate" in Lanka Mahavidyalaya Campus and all students completed their course. Further, out of 50 students, 47 Students got placement as per ASDM provisions. This organisation, MS-7, conducted another Job Oriented Course under ASDM as per MoU in 2018-19 and out of 34 students, 24 students got placement as per provisions of ASDM. Moreover, the various Cell's and Committees under IQAC, Lanka Mahavidyalaya conducted some awareness and Career Guidance Program to orient the students to work hard for the development of their Skill and expertise level in the present competitive scenario. During the Session 2021-22, the College has initiated various Add on Certificate Courses with a great effort to orient the students with the skill based education. The premier departments that stared above mentioned Add-on Courses are as follows- Assamese (Certificate Course of Assamese DTP), Economics (Certificate Course in Eco Tourism and Travel Management), History (Certificate Course on Historical tourism and travel Management), Mathematics (Certificate Course in

	Basic Computer Application), Commerce (Certificate Course in Goods and Service Tax). Under the Direct initiatives of the college two important Certificates Courses had introduced viz. the Certificate Course in Yoga and BORGEET, the Vaishnava Songs composed by Great Vaishnava saint Sri Sri Sankardeva of Assam.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The Institute has Six Communicative Languages, viz. English, Assamese, Hindi, Bengali, Manipuri and Nepali. All the departments arranges Lectures, Talks and workshops on various occasions from time to time and every department offer their cooperation on others' departmental activity. Hence, a good relation and integration has been developed among all the communities irrespective of their mother tongue within the institution , which has a good effect on the entire locality. Further, there is a language society for orientation among all the above six Languages, and the authority has entrusted a responsibility to the society to enhance the communicative skills among all other language speaking people. Further, the webinars on various Languages , Literature and Culture ,arranged by various language Departments of College , attended by various community people all over India, which contributes to some extent to Nation building. Awareness Courses in Yoga is introduced and also Certificate Course in Traditional Assamese Vedic Cultural Song " BORGEET" is being introduced, which is promoting Indian knowledge system. Further, in Assamese Language and Literature, Bengali Language and Literature, Hindi Language and Literature, a major portion is covered by studies on Vaishnava Saint Sri Sri Sankardeva's Creation, viz. BARGEET, NAMGHUSA, KIRTANA, ANKIA-VAUNA ( Vaishnava Drama), Veda- Vedanta etc. In Bengala Language and literure, a major portion is covered by studies on Vaishnava Saint Sri Sri Sankardeva's Creation, viz. BARGEET, NAMGHUSA, KIRTANA, ANKIA-VAUNA ( Vaishnava Drama), Veda- Vedanta etc. In Bengala Language and literure, many courses are included about creation of Kavuguru Rabindra Nath Tagore and his contemporary studies, Swami Vivekananda and his philosophy, Gandhian thoughts and many courses related to Indian knowledge system. In the syllabus of Political Sciences and Economics, Indian knowledges system courses like ARTHA-SASTHA of CHANAYKA allies KOUTILLA , Rajdharma of

	VED-VYAS, Gandhian Philosophy , Gandhian Economy etc. played an integral part in course curriculum. In the syllabus of Philosophy, Gandhian thoughts, Philosophy , Vedic-Culture and thoughts etc. enriched the Indian knowledge system. In the syllabus of History, studies in Vedic Indian civilizations, Studies in ancient Indian History & civilization , medieval studies of Indian states, its Art & culture, sacrifices etc. enriched the Indian knowledge system studies. In the Syllabus of Hindi, studies on all Indian cultures & languages, comparative Indian literatures and Vaishnava Literate played an integral part, which enriched in studies of Indian knowledge system . Thus, the institute played an integral part in practice and promotion of Indian knowledge system
5. Focus on Outcome based education (OBE):	Outcome-based education aims to create a clear expectation of results that students must achieve. Here, the outcome includes skills, knowledge and attitude. OBE empowers students to choose what they would like to study and how they would like to study it. The Institution has already adopted Outcome Based Education (OBE), as the syllabi prescribed by the affiliating university under CBCS system is already in synchronous with the expectation of the program and the desired skills and knowledge to be inculcated in the learners. The institution is planning to organized workshops and faculty development programs in order to develop materials for OBE. Collecting data from the outcomes, like percentage of placement, opting higher studies and clearing different competitive exams, through feedback the institution tries to ascertain it's focus on OBE . Further, the institute took initiatives to offer Job oriented Skill Development courses under Assam Skill Development for its students during last five years and signed MoUs with Training Partner Institutes of Assam Skill Development Mission,viz. MS-7, Rout to Success ( 2018-19), Indian Skill Academy ( 2020) and Skillfinity ( 2022 ) to provide the same. Under this initiatives, all total 75 students got placement as campus placement. Further, sufficient numbers of passed out students got placement in various organisation as mentioned in Criterion-5. Further, the college is offering Skill Enhancement Courses in various UG Programs as per regulation of the Gauhati University CBCS System

	and NEP-2020, which is focusing on OBE of the institute.
6. MA in Assamese, English, Education, Political Science, Sociology , Economics and M.Com through Distance Education. Also, the college had offered Diploma in Elementary Education till 2018 and Bachelor Preparatory Program for 5 years till 2017 under KKHSOU. From the session 2023-24, the Study Centre of KKHSOU adopted the NEP-2020 in the line of Government Order and Notifications regarding the implementation of NEP. ONLINE EDUCATION : The Institution provides complete online classes for regular curriculum during Covid-19 Pandemic lockdown period and arranged online Seminars / Webinars for both Teachers and Students. During Covid-19 Lockdown period the IQAC, Lanka Mahavidyalaya organized about 20 Webinars (Link of the Webinars in Institutional Website: http://www.lankamahavidyalaya.in/iqac_sub.php?id=5 ) , relating to Students Mindset Crafting, Students Career Related Program , Research Oriented Programs, Intellectual property Rights, Gender Sensitization , Mental Health, Soft Skill Development, Online E-Resources, opportunities of research in various field , and also online examination System, etc. Further, the institute prepared Online Academic calendar for regular online Zoom- Platform classes , specially to overcome covid-19 pandemic crisis. The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

### **Response:**

Lanka Mahavidyalaya is affiliated to Gauhati University, Assam and it follows the syllabus, academic calendar and guidelines framed by the university. The college has been following a well-planned curriculum delivery system. The institution has an academic council which formulates and ensures curriculum planning in association with Management and IQAC, Lanka Mahavidyalaya.

The Academic Council of the Institution prepares a prospectus for the students to have a glimpse of the curriculum followed by the college. The students can acquaint themselves with the curriculum and other relevant information such as notifications related to form-fill-up, admission, examination etc. by accessing the college website as well as the notice board displayed in each department.

Further, the Academic Council of the Institution prepare Central Class Routine ,Academic Calender and internal examination schedule.

Some of the faculty members of the college also involved in revising the course curriculum by offering suggestions in the Board of Studies (BoS) meeting convened by the university. Each Department prepares class routine so as to cover all the courses as per University/ Board rule for timely completion of the entire volume of the courses. The Head of the department distributes routines to the concerned teachers with class and time allotment which is being followed both in odd and even semesters during each academic session.

For the slow learners and other students desirous of clearing their doubts and queries, there is a provision for additional remedial, tutorial and practical classes arranged by the concerned departments.Each department prepares a well designed Teaching Plan to have effective impact on the learning process for the students and it also helps the teachers to be more effective in the classroom by providing a detailed outline to follow in each class period.The teachers also get involved themselves in various co-curricular activities such as excursion, field study, sports, cultural activities to excel learning by stimulating creative thoughts, help them identify and develop their specialized skills. Sessional Examinations, group discussion, presentation on course contents are conducted as a part of internal assessment and for the overall development of the students.

Records of various activities are properly maintained and documented by every department. It is forwarded to IQAC for official records and regularly uploaded in the college website. Departments conduct departmental meetings at regular intervals to analyze the progress of the course and discuss other important issues concerning the students, department and the college. Online feedback of the students are taken to examine the drawbacks of the teachers as well as the college in understanding the subject matter

and provides clear guidance on how to improve their learning procedure. The feedback reports are being stored in the departmental personal profile page so that every teacher can access to it and resolve their drawbacks. Parents feedback also is in practice to discuss the students progress at college and find solutions to academic or behavioral problem.

### 1.3.1

### Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability in transacting the Curriculum

### **Response:**

The institution makes efforts to integrate its crosscutting issues such as Professional Ethics, Gender, Human Values, Environment and sustainability into the curriculum. By adhering to the curriculum of the affiliating university, crosscutting issues such as climate change and environmental education are made compulsory subject for all the students in the higher secondary and degree level.

The Institute organised about 65 Workshops and Seminar/ Webinars to promote Professional Ethics, Reseach Environment, Human Values, Environmental Awarness cum protection, Soft Skill Developement, Intellectual Property Rights, Gender Sensitization, Career Developement, Concept of Self-Employed etc.

Further, the Institute organised one Faculty Development Program on the topic, "Behavioural Remodelling and Use of ICT Tools for Class Room Delivery of Teachers", in Association with E &ICT Academy, IIT Guwahati, to promote professionalism and ICT orientation among faculty members.

Firther, the institute organised workshops on E-College and Process of Academic & Administrative Audits to develope professionalism among Teaching and Non-Teaching Staff.

Under the guidance of concerned supervisors, by visiting local areas; students undertake field work and prepare a project after having a clear understanding of various environmental issues and the measures which can be undertaken in order to protect the environment.

To bring about greater awareness about the harmful effects of tobacco use and about the tobacco control laws, an awareness campaign was organized in collaboration with District Tobacco Control Cell, NTCP,

## 2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

**Response:** 

To ensure that internal/ external assessment is transparent, the college follows strictly the guidelines and rules issued by the affiliating university while conducting internal and external examinations.

At Institute level: At Institute level, an examination committee, comprising of a senior teacher as convener and other teaching and non-teaching staff as members is constituted to handle the issues regarding conduct and evaluation process of the internal as well as external examinations. The Committee formulated the schedule of the internal examinations centrally and various Departments conduct their sessional examinations (Internal Examinations) as per direction of the Internal Examination Committee. After evaluation of the answer scripts, the internal marks are displayed on the notice board.

**For External Assessment :** The External Assessment is conduct by Gauhati University, which is the affiliating university of Lanka Mahavidyalaya.

The university conduct the final Examinations of each Semester and before examination the university notified for necessary formalities such as Registration, Form Fillup and deposition of required fee . Next the university notified examination schedule and as per direction of Gauhati University, the college constituted Examination committes headed by the Principal, which is responsible for conduct the examinations as per university regulation and to sent the seal packed answr scripts to concerned Evaluation Zones as specified by the university for assessment. After completion of the examinations, the designated evaluation zones examine the answer scripts and send to the Controller of Examination , Gauhati University after scrutiny . The university after verification, declare results as per university regulation to complete the assessment process.

Further, if students have grievances related to evaluation of university answer scripts it is intimated to the Controller of Examination through Head of the Institute for Re-Evaluation of the answer scripts.

#### In Highlighting point wise, the college follow the following process in Internal Assessments :

\* The Institution is affiliated to Gauhati University and it follows the guidelines of the affiliating university in examination related matters both internal and external assessment.

\* Attendance, assignment and sessional examination are the three components of the internal assessment mechanism.

\*Academic calendar of the institution incorporates schedule of internal assessment.

\*Students are informed well in advance regarding schedule of sessional examination and assignments and display in notice board as well as in College Website.

\* An Examination Cell is formed at the beginning of the academic session. It is responsible for smooth conduct of both sessional and end semester examinations.

\*The departments are entrusted with the responsibility to prepare the question papers and submit the same to the Examination Cell on time. Invigilators are appointed from other departments.

\* Invigilators are assigned in examination halls and rooms depending on the number of examinees. The

Examination Cell is also responsible for determining the date by which the sessional examination's evaluation procedure must be finished.

\* The evaluated versions of the students' answer scripts are distributed to them, and the results of the sessional test are posted on the bulletin boards within the relevant departments.

session.

Orientation on the POs, Cos, and PSOs is also provided to recently appointed permanent, part-time, and contractual faculty members.

The sessional and end-of-semester examinations, classroom engagement, assignments, class quizzes, and other activities are some of the ways that outcomes are measured.

The results of the sessional exam and the students' participation in class are used to determine which students are considered slow learners and which are considered advanced learners. This is done so that attention can be directed toward the desired goals.

The following strategies and procedures are implemented in order to evaluate whether or not the programme and the course have been successfully completed:

The performance of the students in class tests, sessional examinations, and final examinations at the conclusion of the semester all help the teachers evaluate the students' learning outcomes and attainment.

In addition, the students' performance on things like assignments, seminars, quizzes, and group discussions, as well as project work, practical and laboratory work, and so on, provide valuable information into the students' learning levels and levels of achievement.

Following the publication of the results of the sessional and end semester examinations, an evaluation and analysis of the students' performance might take place.

The teachers and mentors put in consistent effort to ensure that all of the students, including the fast learners and the slow learners, achieve their POs, PSOs, and COs.

Regular feedback from the students is collected in order to gain a better understanding of the students' overall experiences and accomplishments while attending the institution.

Lanka Mahavidyalaya evaluates the Programme Outcomes, and Course Outcomes through assessment efforts of concerned departments. The students are then formally communicated through means of discussion in the classroom, departmental notice board and online departmental interface.

In the process of evaluation it is found that the strength of the students and their passing rate has been steadily upward.

In addition, it appears that during the past five years, students' transition to higher education from the institute i.e. from Undergraduate to Postgraduate and other sector of services has increased effectively. The ratio of student placement has also been in upward trend. Institution measures the level of achievement of POs and COs with the utmost care and according to established guidelines of the University and Academic Calendar and Routine. Also evaluation is done on basis of internal exams, project works and class test.

Further, many departments organized field survey for their project papers for better understanding of programs and better outcomes of the courses.

The college organized many other programs, viz. quiz, debate, essay writing competitions to test the outcomes of the implementation of the programs.

The various Departments in Arts and Commerce streams are located in separate blocks. The Library building is also situated in a different block. Moreover, the college also runs a study centre under Krishna Kanta Handiqui Open University in a separate building. The College is planning to introduce Science Stream too, for which a separate science building is under-construction. The college has adequate classrooms, laboratories, digital and other facilities for effective teaching-learning process.

Apart from providing adequate infrastructure for academic excellence, the college also has adequate infrastructure for sports and co-curricular activities too.

The Institution has established a mechanism for conducting internal and external audits on the financial transactions every year to ensure financial compliance. It follows a mechanism for audit of all financial activities. The college has two tier audit system-

#### **Internal Audit**

- The **Internal Audit** is conducted for every financial year by a Chartered Account firm appointed by the college authority. M/S Satya Narayan Agarwalla & Company, a charted Accountant firm based in Nagaon, Assam is entrusted the responsibility of conducting internal audit of the college. On behalf of the Principal of the college, the Head Accountant maintains the funds. The internal audit report is placed before the Governing Body of the college for necessary approval.
- Internal audit includes the auditing of all the Government and Non-government funds as mentioned in Sources of Funding .

#### **External Audit (Government Audit)**

- The External Audit (Government Audit) is conducted by the Directorate of Audit (Local fund) Govt. of Assam. The Directorate of Audit (Local Fund) verifies the utilization of funds received from various sources such as Central Government, State Government and all other sources which include the grants received from UGC, RUSA & Infrastructure Development Grants from Government of Assam etc.
- The financial transactions that come under the purview of RUSA funding are audited by RUSA, Assam.
- The audit team verifies/checks whether utilization of fund is done in accordance with the accepted procedure. Tenders and quotations are verified by the Assistant Director of Audit (Local Fund). Their suggestions are incorporated in planning the effective utilization of funds.
- The Assistant Director of Audit (Local Fund) is authorized to audit the books of accounts and necessary documents of the college related to general revenue of Govt. and utilization and non-utilization details of the funds.
- The audit team scrutinizes and verifies Cash Book, Bank Passbook, Acquaintance of teaching and non-teaching staff, SC/ST/OBC scholarship acquaintance, Cheque issue register, Deposit and fee receipt voucher etc.

#### Title of the Practice: LANKA MAHAVIDYALAYA STAFF CO-OPERATIVE SOCIETY LTD.

The Lanka Mahavidyalaya Staff Co-operative Society Limited has been controlling the spendthrift habit of members by savings in the co-operative society and also has made a significant contribution in improving the socio-economic conditions of its members and the students.

**2. Objectives of the Practice:** Following are the main objectives of Lanka Mahavidyalaya Staff Cooperative society:

? To promote social and economic betterment of members through self-help and mutual aid in accordance with cooperative principles.

? To raise fund for the business of society and development of the students who are economically weak.

? To grant loans and advances to the members associated.

? To constitute various funds for the welfare of the members and the society.

? To provide facilities for the exercise of Thrift and savings.

? To utilize the proceeds of the income for the welfare of the students.

? And generally, to do all such other things as are incidental or conducive to the attainment of its objectives.

#### 3. Context:

In the year of 1989, Lanka Mahavidyalaya staff Mutual Fund was established and all the Teaching and the Non-Teaching Staff of the Institution become the members of this Mutual Fund. Later on, in the year 1995, this Mutual Fund was registered under Assam Co-operative Societies Act as "LANKA MAHAVIDYALAYA STAFF CO-OPERATIVE SOCIETY LIMITED". The society was formed to promote saving practices and welfare of the students. It was registered in the office of the Assistant Registrar of Cooperative societies, Hojai (Nagaon) under Assam cooperative societies Act, 2002 (Assam Act IV of 2017) on 1995 and is functioning till now.

#### 4. The Practice:

**Bye- Laws:** The society doesn't have its own Bye Law, but it follows the rules and regulation of Assam Cooperative Societies Act 1949, which is amended by the Assam Legislative from time to time.

**Membership:** Both teaching and non-teaching staff who are working in the college fraternity can become the member of society.

Administration/ Governance: By following the rules and regulations or Bye-Laws (Assam Cooperative society Act, 1949) the society have a Board of directors that consist of 15 members, out of which two members are reserved for Female.

**Pattern of Loan/ utilization of fund:** The secretary is responsible for Sanctioning loan to its member. There are two types of loan, that is general loan and the other one is special loan. The rate of interest for general loan is 1% per month and for special loan is 1.25% per month.

- Fund Generation: The capital of the society is generated in the following manner:
- By sale of shares to its members.
- Each member of the society is required to contribute up to maximum of Rs 5000 per month @ Rs.500/- per share.
- **The Fund (Members' Contribution)** is realised from Salary Deduction by Office of the Principal as authorised by the members and recommended by the Secretary of the Society.

#### **Evidence of success:**

? The initiative of providing scholarship to meritorious students is an encouragement and benefit to the students every year.

? A regular saving habit for the members of the society has been increased.

? During financial emergency such as medical, the society has been providing financial assistance to its members.?

? A steady secondary income in the form of interest and dividend has been provided to the members of the society.

- To develop Pisciculture in College Pond on commercial basis.
- To Make the College Campus suitable for study.
- To make the college campus free from Dust and Noises.
- To make the College Campus a leisure friendly.

- The Context:
- Since, the girl's students of the college constitute more than 60%, all efforts are being taken for their upliftment. Moreover, majority of them come from rural areas, where miserable conditions of utter poverty, illiteracy, ill-health and superstition take hold of their lives. Thus they are doubly affected by the backwardness and discrimination. So, the college has resolved to take up the cause of Girl Students as well as for the women staff of the college too. Also, about 50% employee of the college are Women, so the college is trying its level best to give assurance of security both mental and physical so that both the Girls Students as well as working Women may get a comfortable environment for their study as well as day to day work. Hence for safety and Security of Women , special measures are adopted by the college community.
- The College has a large Pond of area about 8 Acres of Land and the College Authority formed a Pond Development Committee on 17/08/2009 to develop fish cultivation in commercial basis. The committee in its meeting on 20-08-2009, 24-05-2010, 29-06-2013, 07-11-2014, 03-11-2016, 04-08-2018, and 13-06-2019 adopted special measures for profitable farming of fish in the college pond. Further, the college planted coconut trees on both sides of the pond to encorage students for pisciculture as well as coconut cultivation.

#### **Response:**

Distinctiveness of Lanka Mahavidyalaya

#### **Priority and Thrust Area : Educational Environment**

Lanka Mahavidyalaya was established on 20th July, 1979 and is situated in a Schedule Cast area, in the outskirt of Lanka town and situated in the southern most part of the Hojai district of Assam, at a distance of 180 KM from Guwahati, the capital city of Assam, which is well connected by both Train and Bus. The site where the college stands today spread over an area of 17 Acres amid green surrounding on the bank of a big pond covering an area about 8 Acres.

The College started its mission with only 130 students at Lanka High School Premises & shifted to present campus in 1982. At present the College is having a total of more than 2300 (Including ODL Students) enrolments which reflect the progress of the Institution day by day.

The Lanka Mahavidyalaya has been contributing towards providing quality higher education to the students of the socio-economically backward locality of Greater Lanka Area and bordering localities of Hill Districts, viz. Kheroni, Howaipur, Mailu, Jhengkha, Jirikinding etc. of two Karbi Anglong Districts and Mailu, Doyangmukh, Dehangi etc. of Dima Hasao District. The student community belongs to multicultural ethnic groups which fall under SC, ST, OBC, and General category. It offers different category of scholarship and awards to meritorious and economically backward students such as Awards from Lanka Mahavidyalaya STAFF COOPERATIVE SOCIETY and also National Scholarship (Government Sponsored). Moreover, Lanka Mahavidyalaya provides financial aids to poor students from Lanka Mahavidyalaya Students' Aid Fund.

Though the campus is on road side of East West corridor (NH -27), yet the campus is free from noises of highway vehicles. Moreover, with its Highway noise free environment, the calm and green campus along with the large pond enriched the campus to a peaceful, healthy and education friendly environment.

The College has taken up the necessary initiatives and steps for the safety and security of women within the college campus. For which the College is equipped with CCTV cameras, and other administrative mechanism for safety of women, namely Women Cell, Discipline Maintenance Committee, Grievance Redressal Cell, and Anti-Sexual Harassment Cell, which later on converted to Internal Complaint Committee (ICC).

### The one of the most important characteristics of the Institution is that, it provides Six Languages in course curriculum, viz. Assamese, Bengali, Hindi, English, Manipuri and Nepali.

Regarding distinctiveness of students, most of the students belong to families of small-scale farmers and businessmen and the students offer support to their parents and guardians in earning their livelihood, namely, agriculture or running their family business. Moreover, the NSS Unit of Lanka Mahavidyalaya have shown their interest in social services, viz cleaning their locality after festivals, offering their service in making the institute plastic & garbage free, patronizing Free Blood Donation Camp, Swacha Bharat Abhiyan etc, and the NSS unit is able to got prizes in March-Past competition in Republic & Independence Day Parade organised by District Administration.

In Cultural and Literary activities, the students are very active.

The college is continuously publishing its Annual Students oriented Magazine," RANGMAHALA JEUTI" and the students contributed to the magazine with their articles and poem on various topics. In 2021-22, The College Magazine got 3rd Prize in the Magazine Competition, organized by one of the largest NGO of Assam, The Assam Sahitya Sabha.

The Lanka Mahavidyalaya has Study Centre under KKHSOU from the Academic Session 2011-12 to meet the growing demand of the locality for Higher Education. The main objectives of the study centre are:

- 1. To provide access to higher education in **Open and Distance Mode** to large segment of the population, in particularthe disadvantage groups such as those living in remote and rural areas including working people, housewives and other adults who wish to upgrade or acquire knowledge through studies in various fields.
- 2. To strengthen and diversify the degree, diploma and certificate courses related to the needs of employment and necessary for building the economy of the country on the basis of its natural and human recourses.

Also, one of the most important characteristics of this institute is that most of its Alumni engaged themselves either in Self Employment or small scale Entrepreneur rather than job seeker.

The College has Central Library, Reprographic Center, Digital class rooms, Central Computer Lab / Language Lab with internet facility, Playground, Indoor stadium, Gymnasium, Canteen, Pure drinking water & maintaining a Green Campus with a Large Pond Covering an area of about 8 Acres of land.and college practices pisciculture since long and earning income for financial support of the institution.

The institution has initiated self financing professional and job oriented courses likeHindi Translation and Short Term Skill Dev.Programs under Assam Skill Dev. Mission from time to time.

Thus, we may summarize about the distinctiveness of the institution with the following remarks -

- 1. Providing quality higher education to the socio-economically backward localities of greater Lanka area and few parts of the neighbouring Hill districts.
- 2. Though the Institution is located on the road side of East-West Corridor (NH-27), yet the campus is free from Highway noises and maintained a cold, peaceful and healthy educational environment.
- 3. It has been catering to the needs of students belonging to different ethno-cultural groups.
- 4. Except for the UGC and state sponsored fellowships, the College has been providing financial aids to students coming from most economically weaker sections.
- 5. Though the college is situated in a backward area, yet the college is equipped with modern amenities, like Computer Lab, Internet, Central Library, Power Backup, good drinking water, adequate class rooms, sports facilities, career guidance facilities and a few audio visual class rooms etc.
- 6. Safety and security of the women has always been the top priority of the College.
- 7. 'After Graduate engagement' has been encouraged by the College through various entrepreneurial workshops and skill development programmes.
- 8. For the students, deprived of formal higher education, the College has been providing the opportunity by introducing Open and Distance Learning Mode viz. KKHSOU.
- 9. The NSS Unit of Lanka Mahavidyalaya has been actively involved in community service since its inception.
- 10. The Alumni of the college are unique in the sense that they are mostly self- employed rather than job seekers.

In every year, IQAC of the College conducts one workshop/Seminar on Intellectual Property Rights and Gender Sensitization for promoting the awareness among the students and teachers regarding IPR and Gender equality.

The Instite have carried out a number of extension activities under the auspices of the NSS, and different cells, departments, and associations in the neighborhood community in terms of impact and sensitizing the students to social issues for their holistic development during the last five years.

The Alumni Cell of the College conducted one Inter District Badminton Tournament in the year 2021 to create awareness on Sports in the neighboring Community.

During the session 2022-23, the College Magazine viz. RANGMAHALA JEUTI got the 3rd Prize, in the State Level Magazine Competition organized by the Prestigious "Assam Sahitya Sabha" in memory of LATE RANJIT BORPUJARI.
